Orange County Employees Retirement System ("OCERS") is in receipt of your second amended Public Records Act request dated August 25, 2009. Your revised request asks for the name, pension amount, and agency last worked for those retirees who receive a benefit of more than \$100,000 per year from OCERS as well as the pension amount, job title, and agency for those who receive less than \$100,000 per year.

Enclosed please find a list of the agencies and yearly benefit amounts for OCERS benefit recipients. This list is being provided to you in compliance with your second amended public records request.

As explained in responses to your first two requests, OCERS cannot provide names of benefit recipients tied to benefit amounts because OCERS interprets these records as being individual member records. Any disclosure of such records without written authorization from the affected members or an order from a court of competent jurisdiction would violate Gov. Code § 31532. Furthermore, these records are exempt from disclosure under sections of the California Public Records Act found at Gov. Code §§ 6254 (k) and 6276.12.

OCERS cannot provide you with job titles of any benefit recipients because OCERS does not track job titles and is not in possession of that information. Also, OCERS did not track agencies until after 1998. Therefore, there are a number of benefit recipients whose last known agency is unknown.
