May was a more volatile month with the markets bottoming out in the middle of the month and climbing back up to the status quo. Year to date the portfolio is up 5.7% net. The debate on inflation continues and markets will likely be working through it for the rest of the year. Unemployment will continue to be a challenge as the economy reopens. Commodities are up and still on the rise due to a weakening dollar. There are rumblings of a commodities super cycle. The growth to value rotation continues.
