S&P 500 hit a new high as of today. She also noted that there is an increased bottleneck in the supply chains of manufactured goods. COVID is overshadowing the oil demand as oil fell to \$67. COMMITTEE MEMBER COMMENTS

Mr. Dewane proposed moving to a quarterly Investment Committee meeting schedule to free up staff's time to manage the \$22 billion fund. This item will be added to the October Investment Committee meeting.

CEO COMMENTS

Mr. Delaney shared that Board Chair Dewane directed the Strategic Planning meeting agenda has been shortened from two 7 hour sessions to two 3.5 hour sessions due to concerns with Zoom fatigue and has further directed that the annual workshop take place in a completely virtual format due to minimal in-person participation and an increased anticipated cost due to A/V rental requirements to accommodate the hybrid model.

Vision 2030 will be shared during the Strategic Planning meeting and will include consideration of a future AI Pension Administration System. Mr. Delaney will send to Trustees a news article in this field, indicating that Ontario Municipal Employees Retirement System (OMERS) is already heading down that path, not surprising for a system that was the first in North America to accept online retirement applications.

The Personnel Committee will meet in September. Mr. Dewane and Mr. Prevatt will follow up with staff for potential meeting dates.
