CIO COMMENTS

Ms. Murphy prefaced the 9/30 numbers would be presented. Since those reported numbers, she noted there was a rise in the market likely to affect the final numbers at the end of the year. The Western states are feeling the current inflation, particularly at the gas pump. There has also been a food inflation spike with inflation over 5%. The Investment Team is watching how the supply chain is affecting inflation. The buildup of empty containers are moving out of the congested ports. The dollar remains strong and the looming debt ceiling expires on 12/15. The equity markets are still strong despite all that is going on. The OCERS portfolio is up approximately 15% YTD.

Ms. Murphy also provided an update on the progress of the Investment Consultant RFP, advising that the process in on schedule with the consultant semi-finalist Zoom interviews scheduled to take place in December.
