Pre-Retirement Seminars

While it's easy to live for today, the transition into retirement requires plenty of advance planning. OCERS is offering Pre-Retirement Seminars this summer to help you gather information you'll need to meet your retirement goals.

The few hours you spend at the seminar can have a beneficial and long-lasting impact on your quality of life after you retire. Anyone who is within three years of their retirement date should plan on taking this seminar.



These daytime seminars will be held at OCERS, 2223 E. Wellington Ave., Suite 100, Santa Ana, from 8 a.m. to 1 p.m. on July 7 and 21; Aug. 4 and 18; and Sept. 8 and 22, 2010. The one-session, five-hour seminar is free, and there is plenty of free on-

site parking for those attending.

Various topics will be covered. A Social Security representative will discuss Social Security and Medicare benefits; a representative from "Deferred Compensation" will discuss the County's 457 plan; a representative from Retiree Medical will discuss the County's retiree medical benefit options; and an OCERS Retirement Specialist will focus on your OCERS retirement benefits.

No advance registration is necessary and this information will help prepare you for the move into retirement. Members are welcome to take this seminar as often as they like.

What is a public record?

OCERS is subject to the California Public Records Act, which requires that certain records be disclosed to the public if requested. OCERS is also subject to certain provisions of the California Government Code known as the '37 Act, which states if an individual member record is requested, and disclosing it is not necessary for the administration of OCERS, then written permission from the member or a court order is necessary before OCERS can release the record.

There are certain pieces of information that are already publicly disclosed by OCERS at its board meetings. These are the names of members who have filed for retirement along with the agency they work for, and additionally, in the case of members who file for disability retirement, the last position held. Also, we disclose the names of members and beneficiaries who pass away.

Last year, an organization called The California Foundation for Fiscal Responsibility, (CFFR), requested the name, monthly pension amount and last agency worked for all retirees and beneficiaries receiving \$8,333 or more in any month in 2009. OCERS denied the request and advised CFFR that they either had to obtain written permission from each retiree and beneficiary or a court order. CFFR filed a writ in Superior Court to obtain a court order and was successful.

The order was not limited to just the retirees and beneficiaries receiving \$8,333 or more in any month. The court addressed the type of records being sought, i.e., the name, pension amount and last agency worked, and concluded that those three components were not considered an individual member record and therefore not confidential.

What does this mean for OCERS' members and beneficiaries? It means that, if requested, OCERS is now required to disclose the name, pension amount and last agency worked for any retired member or beneficiary, regardless of the amount of their benefit. Other information that constitutes individual member records, such as a member's age, address, social security number, and telephone number will not be released without either written permission from the member or beneficiary, or a court order.

OCERS will post all public records requests on our Web site along with an indication of which records we will disclose, so each member and beneficiary can see what is being requested and what we plan to release.

OCERS' Web site offers key resources for Retirees

Since the introduction of the Member Information Center on OCERS' Web site in 2007, thousands of OCERS members have taken advantage of the growing number of resources on the Member Information Center (also known as the "MIC").

In recent months, the MIC has been enhanced so Retirees will find it easier to use, even while the interactive site provides them the ability to access a growing number of key resources 24 hours a day, seven days a week.

One of the new features available on the MIC is the ability for OCERS to post both all-retiree and member-specific announcements in an individual member's account. So for example, if OCERS is mailing out 1099-R forms on a specific date, an announcement can be posted on the home page of any Retiree visiting



the MIC. But if OCERS is having trouble getting an important notice to an individual Retiree, a specific message for that person can quickly be posted on the home page of that member's MIC account. This dynamic technology is one of many ways OCERS is hoping to improve service.

Once a Retiree has logged into their account using their User Name and Password, there are easy-to-use tabs at the top of the page that allow the member to navigate throughout the site. On the "Profile" page, Retirees can confirm important information such as the names of their beneficiaries and the percentage in their COLA Bank. The "Tax Withholding" tab allows retired members to change their tax withholding amount utilizing both Federal and State of California sections displayed on the screen.

One of the most useful tabs is the "Payment History" page, where Retirees can view details about their 13 most recent benefit payments and print out copies of their pay check stubs. Another tab provides "Direct Deposit" Account information and even allows a Retired Member to make changes online. Finally, another tab provides "1099" information and allows members to print their 1099-R information.

If you have lost your PIN number and/or have never used the MIC, you will need your PIN to create your "User Name" and "Password." To get a PIN, please call OCERS at 714-558-6200. To access the MIC, please visit **www.ocers.org** and click on the Member Information Center "Member Login" button.

And of course, the MIC has a number of resources for both active and deferred members as well, including the ability for them to gain access to details about their beneficiaries, employment history, benefit formula ("Plan Type") and even use an interactive Benefit Estimator to calculate their retirement.
