## **Security Tips to Help Keep Your Information Safe**

OCERS is committed to the security of your retirement We have various benefits. systems, controls, and measures in place to safeguard your personal data. We are constantly evaluating improvements to our systems and procedures to ensure

the highest levels of security possible.

At the same time, it is important for our members to maintain their own personal data security as well. We offer the tips below to help you safeguard your information.

#### **Internet Security**

- Do not perform certain activities that involve sensitive data, like online shopping and banking, on public Wi-Fi networks
- have the padlock icon in the address bar, etc.
- Ensure you are on the official website of the organization you are interacting with; many fake websites look like the real websites
- Only provide information on secure websites; look for sites that start with "https,"

#### **Social Media Security**

- Protect yourself on social media by customizing your security settings and deleting accounts you no longer use
- Double-check suspicious messages from your contacts, as hackers may create fake accounts of people you know
- Don't overshare; disable geolocation tagging, don't share details about family/ friends/relationships, share about places regularly frequent

#### Computer/Mobile **Device Security**

- Update your software regularly and ensure automatic updates are enabled
- Protect your mobile device from unauthorized access by securing it with a PIN, adding a fingerprinting feature, or using facial recognition
- Avoid internet threats by installing and maintaining strong anti-virus software on all your devices

#### **Data Security**

- Shred paper documents that contain personal information, like your name, birthdate, and Social Security number
- Regularly check your financial accounts for suspicious transactions and activity
- Request and check a free credit report from each of the three credit bureaus every year: TransUnion, Equifax, and Experian

## 2024 Retirement Medical Open Enrollment

Mark your calendars! October 18th - November 7th

Open Enrollment for County of Orange retirees will run from Wednesday, October 18, 2023, November through Tuesday, Elections 7, 2023. made during Open Enrollment will be effective January 1, 2024.

Open Enrollment 2024 will bring changes. The County will be offering new plan options to both Medicare and non-Medicare retirees. To ensure you receive all the vital information, take a moment to verify your settings in your communications preferences on the Benefits Service Center website: mybenefits.ocgov.com. Your Open Enrollment notification will NOT be mailed to you if you have your communication preference set for email. also very important to report any change of address with the Benefits Service Center in a timely manner. If you have questions or want to make your Open Enrollment election with a representative, contact the Benefits Service Center at 1-833-476-2347. You can also schedule an appointment for a time and date that works best for you. During Open Enrollment, the Benefits Service Center will be available to answer your Open Enrollment questions between 8 a.m. and 8 p.m. We encourage you to take advantage of the extended hours during Open Enrollment! Carefully review your Confirmation of Benefits (COB) notice if you make elections during Open Enrollment. The allowable correction period is Wednesday, November 8 - Friday, November 17, 2023. In addition, make sure you check your email or mailbox for any follow-up actions from the Benefits Service Center.


